I, for myself, my estate, my heirs, personal representatives and/or assigns, hereby hold harmless, release, and forever discharge ABC from all claims and/or causes of action which I or my child have or may have by reason of ABC’s use of the photos/videos.

**General Liability Waiver**

I, for myself, my estate, my heirs, personal representatives and/or assigns, hereby forever release and waive my and/or my child’s right to bring suit, on my behalf or my child’s, against ABC and/or any of its officers, employees, trustees, volunteers, agents, and/or representatives for any liability, claims, demands, and/or causes of action for any loss, damage or injury sustained in connection my child’s participation as an ABC volunteer or intern, except for ABC’s acts of gross negligence or deliberate misconduct.

**Specific Covid-19 Liability Waiver**

COVID-19 is extremely contagious and can cause serious illness and even death. ABC cannot prevent your child from becoming exposed to, contracting, or spreading COVID-19 while acting as a volunteer or intern for ABC. I have read and

understood the above warning concerning COVID-19, and I hereby choose to accept the risk that my child might contract COVID-19 while acting as a volunteer or intern for ABC.

I, for myself, my estate, my heirs, personal representatives and/or assigns, hereby forever release and waive my and/or my child's right to bring suit, on my behalf or my child's, against ABC and/or any of its officers, employees, trustees, volunteers, agents, and/or representatives for any liability, claims, demands, and/or causes of action for exposure, infection, and/or spread of COVID-19 in connection with my child's actions as a volunteer or intern for ABC, except for ABC's acts of gross negligence or deliberate misconduct.
